The undersigned intends to participate in the "Manatee PAL 30th Anniversary Carnival & Music Festival, to start on Friday, January 11, 2019 from 5pm to 10pm, Saturday, January 12, 2019 from noon – 10pm and Sunday, January 13, from noon – 6pm at The Police Athletic League of Manatee County, Inc. (aka Manatee PAL). Set up is from noon – 4pm on Friday, January 11, 2019. Ready to vend no later than 5pm. This form shall be returned to Manatee PAL no later than December 15, 2018.

In consideration of being accepted as a participant in the Manatee PAL 30th Anniversary Carnival & Music Festival, the undersigned:

- Assumes all responsibility for all risk of damage or injury that may occur to the undersigned or its employees during participation in the Manatee PAL 30th Anniversary. In consideration of being accepted as a vendor in the Manatee PAL 30th Anniversary, the undersigned hereby releases, discharges, and shall forever indemnify, hold harmless, and defend Manatee PAL its members and agents from all claims, demands, rights of cause of action present or future whether known, anticipated or unanticipated, and resulting from or arising out of an incident to the undersigned's participation in the Manatee PAL 30th Anniversary.
- Shall provide Manatee PAL with a certificate of liability insurance listing Manatee PAL as additionally insured.
- Shall provide Manatee PAL with a certificate of license from the DPBR, stating the food vendor is officially a legal licensed distributor of food & beverage in Florida.
- Manatee PAL, its board of directors, staff and or agents shall not be responsible for losses of any kind arising from participating in the Manatee PAL 30th Anniversary.
- Agrees that the vendor shall pay a one-time \$100. fee for participation or space at the event to include all 3 days of the event (January 11-13, 2019) due at the time of executing this contract.
- Agrees and understands that Manatee PAL shall sell food tickets at the event to the patrons to be used exclusively for purchases of the undersigned's foods and or services and agrees to only accept those tickets as payment for said food or services. If vendor is seen accepting cash for food or services, Manatee PAL reserves the right to immediately and at its sole discretion close the booth and have the vendor removed from the premises, and the vendor shall forfeit any funds due from the sale of food or services.

- The vendor shall post signs at its booth displaying the price for its products. The vendor shall provide Manatee PAL with a price list for all merchandise being sold. Vendor agree that no alcoholic beverages will be sold by any vendor, all alcoholic beverages are to be sold exclusively by Manatee PAL.
- Vendor agrees to bundle all tickets and submit along with "Vendor Ticket Receipt" form completed, to the Manatee PAL staff and understands that Manatee PAL shall reimburse the vendor for 70% of the value of the vendor's submitted tickets by check no later than Wednesday, January 16, 2019. The undersigned does have the right to be present when the ticket count is verified by Manatee PAL staff.
- Undersigned agrees that the responsibility of payment of Florida State Sales Tax is the sole responsibility of the vendor and not that of Manatee PAL.
- Agrees to abide by all local, state, and federal laws that may apply, including but not limited to; the health department, and or fire department.
- Agrees and understands that each space is self-sufficient to serve food & beverage.
- Agrees that the undersigned shall have one fire extinguisher no smaller than 10lbs, suitable for the intended use.

The undersigned further agrees I have read and understand all of the requirements as listed above, to participate in the Manatee PAL 30th Anniversary Carnival & Music Festival on January 11-13, 2019. I fully and completely understand all of the rules and regulations and shall abide by those as well as any directions given by the Manatee PAL staff on the day of the event. I also understand that my failure to abide by the rules as defined above or direction given by any Manatee PAL staff member on the day of the event, that Manatee PAL reserves the right to have the vendor removed as defined and outlined above.
